Director, CDRI invites the proposal for the rate contract 2017-18 from the manufactures or their distributors/stockiest for the following categories:

- a. Chemical & Solvents
- b. Biochemicals
- c. Oligonucleotides and Biological Media
- d. Glasswares
- e. Plasticwares
- f. Filters/Filter Papers
- g. Micro Pipettes

Terms and Conditions and eligibility criteria:

1. The firm should provide proposal for different category separately.
2. Hard copy as well as soft copy of the price list should be provided with the proposal.
3. The period of rate contract will be for one year. However, in special case, the period of rate contract may be extended or curtailed.
4. CDRI, Lucknow reserves the right to conclude more than one rate contract for the same item.
5. Terms of delivery will be FOR destination.
6. CDRI, Lucknow is entitled to place orders up to the last day of the validity of the rate contract and, though supplies against such purchase orders will be effected beyond the validity period of the rate contract, all such supplies will be guided by the terms and conditions of the rate contract.
7. The rate contract will be guided by "Fall Clause".
"if the rate contract holder reduces its price or sells or even offers to sell the rate contracted goods following conditions of sale similar to those of the rate contract, at a price lower than the rate contract price, to any person or organization during the currency of the rate contract, the rate contract price will be automatically reduced with effect from the date for all the subsequent supplies under the rate contract and the rate contract amended accordingly."
8. CDRI, Lucknow and/or the firm are entitled to withdraw/cancel the rate contract by serving one month notice on each other. However, once a purchase order is placed on the supplier for supply of a definite quantity in terms of the rate contract during the validity of the rate contract, that purchase order becomes a valid and binding contract.
9. CDRI, Lucknow has the option to renegotiate the price with the rate contract holders.

10. Those firms who are already in current rate contract 2016-17 with CDRI should attach at least 03 purchase order copy under rate contract 2016-17 of the same category in which they are offering proposal.

11. Those firms who are not in the rate contract 2016-17 with CDRI should attach at least 03 current rate contract copy with any Government/Semi-Government/Autonomous organisation with their proposal of same category

12. Director, CDRI reserves the right to reject any proposal for rate contract without assigning any reason.

13. Director, CDRI reserves the right to relax eligibility criteria for rate contract as per the requirement of the institute.

14. The firm should enclose all the necessary documents like copy of PAN card, GST registration No., Registration copy of the firm, Annual turnover of the firm for last 03 years etc.

15. Normally part supply and part bill is not allowed against single purchase order.

16. If the proposal for the rate contract is submitted by the distributor/stockiest, the authorization certificate from the manufacturer for the said rate contract should be attached with the proposal.

17. Only exclusive supplier to CDRI, Lucknow will be allowed for the rate contract items. The name of the supplier must be mentioned in the proposal for the rate contract.
