Small animal ventilator Specifications

- The ventilator should be easy to use while delivering physiologically accurate mechanical ventilation conditions with very simple operation.
- Should have very low noise
- Should be used for both and rat and mouse with heart rate. Further it should not be too
 broad for animals weighing more than 600gm as it loses its efficiency.
- Respiratory and BPM should be adjustable while running between minimum 30 or bettermaximum 400 BPM.
- · Should have anaesthetic port
- Tidal volume delivery of 50ul to 5ml with 0.5 ml increments
- Should be operated at 220-240 volts
- Inspiratory time rate 20-80%
- Tubing should be provided for both mouse and rat and fit to the valve unit tightly without any leak. Preferably the valve unit for mouse and rat should be separate.
- After sales service should be free and within 24hrs of call.
- Should be used for performing 2-3 mice/rat simultaneously
