Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. SPECIFICATIONS FOR TRINOCUOLAR STREREOSCOPIC ZOOM MICROSCOPE WITH DIGITAL IMAGI NG SYSTEM

- **1. Zoom body:** Trinocular Stereoscopic Zoom microscopes with zoom magnification of up to 55X or more with 1X objective and 10X eyepiece. The microscope should have continuous zoom or minimum 8-10 zoom positions for better and more precise magnification.
- **2.Optical system:** The microscope should be with Galilean Optical System or Parallel Optical zoom system or Greenough type optical system. Optics should have resolution of 600 lines/mm or better.
- **3. Observation Tube:** Trinocular Eyepiece tube should be inclined at 30 degrees for better view angle wi th 2-way light selector of 100:0 and 50:50 or 0:100(Binocular: Photo).
- **4.Working Distance:** The minimum working distance should be 80mm or more.
- **5. Eyepiece:** Paired eyepieces with FOV of 22/23mm and suitable interpapillary distance and diopter adju stment on both eyepieces.

- **7. Objective:** The microscope should have a Distortion free plan apochromatic parfocal objective for 1X with N.A 0.1 or better.
- **8. Incident Light source:** Dual interlock type incident light source. LED light guide illuminator should be compact with minimum of 50,000-hour lifetime (approx.) Cold-light fiber-optic illumination to minimize da mage to samples.
- **9.Digital Camera:** Digital color camera with minimum 6.4MP or better resolution. USB 3.0 interface. Cam era: 0.5X C-Mount,Approx Image Size:3088X2076(full resolution),2072 X 2072(square),1544 X 1038 (subsampling 2 X 2-high speed), 1544 X 1038 (binning 2 X 2-high

- **13.** Service support: Since the instrument is critical in day to day studies, a service support should be available within 48 hrs of the breakdown.
- **14.** Scientific Papers: Copies of the scientific papers, references citing all the required applicatios wherein similar model has been used should be enclosed.
