Timing:- Eligible candidates are required to report for the Walk-In-Interview for the position code 001 to 013 will be held on 08-07-2025 and Walk-In-Interview for the position code 014 to 023 will be held on 09-07-2025 from 09:00 am onwards. Candidates reporting after 10:00 A.M will not be entertained. The eligible candidates may appear before the Selection Committee for interview on the date and time mentioned above at CSIR-Central Drug Research Institute, Sector 10, Jankipuram Extension, Sitapur Road, Lucknow-226031. Eligible candidates must bring with them a duly filled application & undertaking (which can be downloaded from our website www.cdri.res.in with original & self-attested copies of mark sheets/certificates etc. along with a recent passport size photograph. Tentative mark sheets/certificates and 'result awaited' will not be considered. Any experience certificate to project personnel shall be issued by the Administration of the concerned Laboratory/Institute. However, any other recommendation letter of reference letter shall be issued by the Principal Investigator/Project Leader in all cases Project Manager and such letter shall not commit on any administrative aspects. For project Manager, such recommendation or reference letter shall be issued by the Director/Head of the Laboratory/Institute.

- (a) इन दिशानिर्देशों के अनुसार लगे प्रोजेक्ट स्टाफ संस्थान के सीएसआईआर औषधालयों में परामर्श और/या उपलब्ध दवाइयों और परिवहन सुविधाओं, यदि कोई हो, की सीमा तक, नियम और शर्तों के अनुसार चिकित्सा सुविधाओं के लिए पात्र होंगे, जो कि संस्थान द्वारा प्रदान किया जाता है।
  - Project personnel engaged as per these guidelines shall be eligible to medical facilities at CSIR dispensaries of the institute, to the extent of consultation and/or available medicines at the dispensary and transport facilities, if any, as per the term and conditions with which it is provided by the Institute.
- (b) परियोजनाओं में लगे प्रोजेक्ट स्टाफ को उनकी इच्छा के अधीन समूह चिकित्सा बीमा योजना के तहत कवर किया जा सकता है, जिसके लिए लागत संबंधित व्यक्ति द्वारा वहन की जाएगी।
  - Project personnel engaged in the projects may be covered under Group Medical Insurance Scheme, subject to their willingness, for which the cost shall be borne by the individual concerned.
- (c) सीएसआईआर मानदंडों के अनुसार महिला प्रोजेक्ट स्टाफ 180 दिनों के मातृत्व अवकाश के लिए पात्र होंगी और पुरुष प्रोजेक्ट स्टाफ केवल दो जीवित बच्चों के मामले में 15 दिनों के पितृत्व अवकाश के लिए पात्र होंगे। इसके अलावा, प्रोजेक्ट स्टाफ को उक्त छुट्टी की अवधि के लिए वजीफा का भुगतान ऐसी छुट्टी लेने और प्रासंगिक चिकित्सा रिपोर्ट/दस्तावेज जमा करने के बाद कार्यालय में दोबारा शामिल होने के बाद ही किया जाएगा।
  - Women project personnel shall be eligible for maternity leave of 180 days and the male project personnel shall be eligible for paternity leave of 15 days only in case of two surviving children as per CSIR norms. Further, the Project Staff shall be paid the stipend for the period of aforesaid leave only after re-joining the office after availing such leave and submission of relevant medical reports/documents.

The project personnel are entitled to avail leaves as per extant rules of CSIR i.e., 12 days of leave (at the rate of one day leave per month). Any leave availed beyond this shall be without emoluments calculated pro-rata.

(e) प्रोजेक्ट स्टाफ को संस्थान की नीति के अनुसार उच्च डिग्री (यानी, पीएचडी) के लिए पंजीकरण करने की अनुमति दी जा सकती है, यदि वे ऐसे उद्देश्यों के लिए निर्धारित सभी आवश्यकताओं को पूरा करते हैं, बशर्ते कि परियोजना की अवधि कम से कम 3 वर्ष हो या संबंधित संस्थान/प्रयोगशाला द्वारा निर्धारित किसी भी अन्य शर्तों के अलावा। पीएचडी के लिए पंजीकरण की अनुमति इस शर्त के अधीन है कि परियोजना का काम प्रभावित नहीं होगा और यह सीएसआईआर/परियोजना के लिए किसी भी वित्तीय दायित्व के बिना होगा। प्रोजेक्ट स्टाफ का कार्यकाल केवल इस आधार पर नहीं बढ़ाया जाएगा कि उसने पीएचडी पूरी नहीं की है।

The project personnel may be allowed to register for higher degree (i.e., Ph.D) as per the policy of the Institute, if they fulfill all the requirements laid down for such purposes, provided that the project duration is at least 3 years or more, apart from any other conditions laid down by the concerned Institute/Laboratory. The permission to register for PhD is subject to the condition that the work of the project is not affected and it will be without any financial obligation to CSIR/Project. The tenure of the project personnel shall not be extended merely on the ground that he/she has not completed the Ph.D.

#### सामान्य शर्ते / General Conditions :-

- 1. एससी / एसटी / पीडब्ल्यूबीडी / महिला वर्ग और ओबीसी वर्ग के उम्मीदवारों के लिए आयु सीमा में छूट क्रमशः 05 वर्ष और 03 वर्ष या सरकार के अनुसार होगी। इस संबंध में भारत सरकार द्वारा समय-समय पर निर्देश जारी किये जाते हैं। The relaxation in the age limit for the candidates belonging to the category of SC/ST/PwBD/Women and the Category of OBC shall be 05 years and 03 years respectively or as per Govt. of India instructions issued in this regard from time to time.
