If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

3. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

Specifications of Tissue Embedding Station

1. The unit must be a microprocessor-controlled bench top model, fully programmable automatic on/off control with two console units one heated paraffin dispensing and embedding unit, and cryoconsole with cooling plate.
2. It must be programmed to turn on automatically to bring all work areas to their proper temperatures in time for the workday.
3. Independent programmable temperature settings for paraffin reservoir, mold warmer, cassette bath, and work surface.
4. The capacity of the tissue storage tank should be 5 liters or more paraffin and a large area of cold plate.
5. Paraffin reservoir temperature setting ranges from 50°C to 70 °C or better.
6. Ample cold plate to accommodate at least 70 blocks.
7. Cassette bath to store at least 300 cassettes.
8. Mold warmer temperature programmable from 50°C to 70°C or better.
9. Work surface temperature programmable from 50°C to 70°C or better.
10. Cold spot temp with Peltier element.
11. The lowest Cold plate temperature -12°C or better and should be adjustable.
12. The system should be operated by manual as well as foot pedal.
13. Spacious paraffin collection tray to collect excess paraffin from the work surface.
14. Separately heated paraffin dispenser with temperature 50°C to 70°C or better.

15. Control panel with LCD showing temperature, time, and filling level.
16. Bright, even illumination of the embedding area to be provided through well-lit and clutter-free - Cool LED lighting.
17. The instrument should be programmable for work days, work starting time, work end time, real-time, and day of the week for automatic switch on/off of the instrument.
18. Should have forceps warmer, along with electrically heated forceps
19. Should have an in-built paraffin trimmer.
20. Super Mega Cassettes should be embedded with ease.
21. Manufacturing company should be ISO Certified.
22. Equipment should be USFDA & European CE approved and as per the Indian Standard Certification.
23. Demonstration of the instrument will be mandatory for technical qualification.
24. Warranty: Atleast 1 year
25. The instruments should be supported with the genius company spare part for at least 10 years.
26. Instrument installation with the installation qualification , performance qualification and operational qualification provide by the company.
27. List of users of instrument of similar specification from the CSIR / other Indian Govt research organization.

Note:-

2. The bidder/manufacturer must have sold at least three installations of similar equipment of equivalent specification. Bidder should attach PO and successful installation certificate along-with the bid. MSEs/Startups will be exempted from past experience as per rules.
3. The bidder has to give a confirmation that the spares for quoted item will be available for atleast ten Years.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
