If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. 3. Preference to Make In India products (For bids > 200 Crore) (can also be used in Bids < 200 Crore but only after exemption by competent authority as defined in Deptt of Expenditure OM dated 28.5.2020): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. Bidders are bound to accept the orders accordingly.

2. Generic

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

1. Dual mode color/ Monochrome camera with 12.37 MP resolution or better for fluorescence microscope.
2. Effective Image resolution of 8192 × 6000 (pixel shifting) 45 Mega Pixel or better, Color CMOS chip size of 1.1inch or better with Global Shutter.
3. Cooling system: Peltier device (active cooling), Bit depth of 12 bit,
4. Life frame rate of minimum 22fps at 4096 × 3000 (1 × 1), 44fps at 2048 × 1500, 60 fps at 1920 × 1080.
5. The camera should have IR cut filter.
6. It should fit for existing microscopes with C mount adapter.
7. Camera should have direct image video port
8. Exposure time minimum 28 micro seconds of better to 120 Seconds or more. It should have One-time automatic exposure, continuous exposure for movies and manual exposure and gain settings.
9. The software should have white balance, black balance and other features like Snap/movie acquisition; Movie playback; Overlay multiple images; Document groups for side-by-side image comparison; Tile view (multiple images in a single data set shown side by side); Time-lapse at specified interval; Geometry/combine/filter processing; Region and line measurements; Interactive measurement; Manual Object Counting, etc.
10. The software should be operated with free perpetual license.

12. The camera should be operated using a windows based computer.
13. It should with power supply of 220- 240V independently.
14. Should not be more than 500gm and place on microscope

The camera should fit for Olympus BX61WI, CKX41 and DMI6000 microscopes
