The acceptance of the quotation will rest with the competent authority of CSIR-CDRI Sector-10 Jankipuram Extension Sec-10, Sitapur Road Lucknow, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject, or partially accept any or all the quotations received without assigning any reason.
- 3. Price quoted should be net and valid for a minimum period of 90 days from the date of opening of the quotation.
- 4. Participation in this tender is by invitation and is not limited to the selected Purchaser's registered suppliers. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of the purchaser and apply for registration as per procedure. It may be noted that Conditional/Unsigned tenders shall not be considered.
- 5. The bidder must submit the applicable Price in BOQ attached and in PDF form also. In case any discrepancy in BOQ price mentioned in PDF Format will be considered.
- 6. Complete specification with manufacturer's name and address should be given while quoting. Literature/Pamphlets should also be enclosed wherever applicable.

#### 19.1 Bidders must read the complete 'Tender Document'.

This NIT is an integral part of the Tender Document and serves a limited purpose of invitation, and does not

#### 19.2 Availability of the Tender Document

The Tender Document shall be published on the CPP Portal (etenders.gov.in).
