The acceptance of the quotation will rest with the competent authority of CSIR-CDRI Sector-10 Jankipuram Extension Sec-10, Sitapur Road Lucknow, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject, or partially accept any or all the quotations received without assigning any reason.
- 2. Price quoted should be net and valid for a minimum period of 90 days from the date of opening of the quotation.
- 3. Participation in this tender is by invitation and is not limited to the selected Purchaser's registered suppliers. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of the purchaser and apply for registration as per procedure. It may be noted that Conditional/Unsigned tenders shall not be considered.
- 4. Complete List with manufacturer's name and address should be given while quoting. Literature/Pamphlets should also be enclosed wherever applicable.
- 5. In cases of agents quoting on behalf of their foreign manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
 - 1. The foreign manufacturer directly or through one Indian agent on his behalf; or
 - 2. Indian/foreign agent on behalf of only one principal.
- 6. The mode of dispatch/transportation/ Installation of the items must be mentioned explicitly in the offer.
- 7. Delivery period required for supplying the material should be invariably specified in the quotation. The offered delivery period shall have to be strictly adhered to in case an order is placed.
- 8. Liquidated Damages Clause for delays: The applicable rate is 0.5% per week and maximum deduction is 10% of the contract price.

16. Notice Inviting Tender (NIT)

The Director, CSIR-CDRI, through the Head of Procurement of the Procuring Entity, in the Procuring Organisation (CSIR-Central Drug Research Institute, Lucknow) invites bid on Proprietary basis for entering into a contract for the supply of Goods (**Bio-Chemicals (As per attached List)**). This Tender Document reference number, Tend No./xxxx (hereinafter referred to as 'the Tender Document'), gives further details.

17. The Tender Document

17.1 Bidders must read the complete 'Tender Document'.

This NIT is an integral part of the Tender Document and serves a limited purpose of invitation, and does not purport to contain all relevant details for submission of bids. 'Tender Information Summary' (TIS) appended to this notice gives a salient summary of the tender information. Any generic reference to NIT shall also imply a reference to TIS as well. Bidders must go through the Tender Document for details before submission of their Bids. However, Bidders must go through the complete Tender Document for details before submission of their Bids.

17.2 Availability of the Tender Document

The Tender Document shall be published on the CPP Portal (etenders.gov.in). It shall be available for download after the date and time of the start of availability till the deadline for availability as mentioned in TIS. Unless otherwise stipulated in TIS, the downloaded Tender Document is free of cost. If the Procuring Entity happens to be closed on the deadline for submitting the bid as specified above, this deadline shall *not* be extended in normal circumstances. Any query/ clarification regarding downloading Tender Documents and uploading Bid on the e-Procurement portal (etenders.gov.in) may be addressed to the Help Desk (contact details given in TIS).

17.3 Clarifications

A Bidder requiring any clarification regarding the Tender Document may ask questions in writing/ electronically from Office/ Contact Person as mentioned in TIS, provided the questions are raised at least before 5 days of bid submission. before the clarification end date mentioned in TIS (or if not mentioned, before 7 days of the deadline for the bid submission). This deadline shall not be extended in case of any intervening holidays.

17.4 Bill of Quantity (BOQ)- Price bid

Bidders should necessarily submit their financial bids in the format provided and no other format is acceptable. The prices mentioned in BOQ/PDF shall be considered for evaluation and comparison of bids. Bidders are required to download the BOQ file, open it and complete the Blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

Price bid in PDF format should also be uploaded along with BOQ in .xls format.

In case of any discrepancy in price quoted in .xls and pdf, price in pdf shall prevail and comparative shall be uploaded on the portal.

18. Eligibility Criteria for Participation in this Tender

Subject to provisions in the Tender Document, participation in this Tender Process is open to single bidder who fulfil the 'Eligibility' and 'Qualification criteria. Bidder should meet the following eligibility criteria as of the date of his bid submission and should continue to meet these till the award of the contract. Bidder shall be required to declare fulfilment of Eligibility Criteria in Form 1.2 (Eligibility Declarations). t:

- (a) be a natural person, private entity, or public entity (State-owned enterprise or institution).
- (b) unless permitted explicitly in TIS/ AITB, not be (or proposes to be, a Joint Venture/ Consortium (an association of several persons, firms, or companies hereinafter referred to as JV/C).
- (c) be a manufacturer of the product offered or be dealer authorized by the Principal/OEM.
- (d) Bidder must fulfill the tendered Lists of the item.
- (e) Bidder must submit duly signed and filled all forms enclosed in the tender.
